

THERAPY AGREEMENT Dept. II

Dear Patient,

You have decided to undergo treatment in our facility - we thank you for your trust! This therapy agreement of Department II applies in addition to the treatment contract between you and API Betriebsgemeinnützige GmbH (hereinafter referred to as Anton Proksch Institute).



Access rule

Personnel and work rooms may only be entered in the presence of employees. Entering other patient rooms is by invitation only. As a rule, rooms occupied by women may not be entered by men. Further restrictions on access are possible for therapeutic reasons. These refer to the progress of your therapy.

Restrictive measures

Therapeutic outings are made possible as part of the treatment programme. During the withdrawal phase, the possibility of external contact is clearly limited.

Mobile phones and internet enabled devices must be surrendered during the stay. During the withdrawal phase, telephone calls are only possible in the presence of therapeutic personnel. Once you have reached the outings status, your mobile phone is available to you at agreed times of day and during outings. For therapeutic reasons, permission to use your mobile phone may be withdrawn. Letter contacts are possible right from the start. Packages and letters must be opened in the presence of therapeutic personnel.

In your rooms and open spaces, you can listen to music from your mp3 player via headphones. Other private music devices, radio (alarm clock), TV, PC, Playstation, etc. are not allowed. Music and television sets for general areas are provided by the ward.

Visits

Visits are possible during visiting hours and in consultation with the therapist. Former patients may only enter Department II by appointment. Visitors impaired by psychoactive substances are not allowed to enter the ward.

Relationships and sexuality

Intimate relationships within the patient group put a strain on the therapeutic climate, distract from one's own therapeutic goals and are therefore not recommendable from a therapeutic perspective. The danger of transmitting infectious diseases (hepatitis, HIV, etc.) also speaks against sexual contact between patients.

Unprotected sexual contacts with the knowledge of a communicable disease constitute bodily injury and thus a criminal offense.

Illness

If you are unable to participate in the therapy programme due to illness, you must inform the medical staff in good time and quietly stay in your room.

Judicial instructions

You alone are responsible for judicial instructions and confirming required therapy sessions or programmes that have to be sent to the respective authorities. The social work staff will be happy to support you in this.

Substitution

We draw your attention to the fact that your responsible pharmacy, the public health officer and your substitute doctor will be informed of your admission. This cancels your current long-term substitution order.

Luggage storage

The storage of your luggage is possible after the end of the treatment in the Anton Proksch Institute for a maximum period of 2 (two) working days. Individual longer-term safekeeping can only be agreed in writing. However, the luggage is stored for a maximum of 3 (three) months and then disposed of.

Drinks containing caffeine and energy drinks

For medical reasons, drinks containing caffeine should only be consumed in moderation. Energy drinks are not allowed.

In order to avoid any discrepancies, we would like to point out that with your signature you agree to comply with the therapy agreement.
